



\$50 New Account Match Deposit Promotion

Official Rules

Promotion Period: The \$50 New Account Match Deposit Promotion (“Promotion”) begins on Thursday September 1, 2016 at 9:00am (Pacific Time) and ends on Friday February 17, 2017 at 11:59pm (Pacific Time) (the “Promotion Period”). The Promotion is only valid during the Promotion Period.

Location: The Promotion is available at all participating CG Technology (“CG”) sports books in Las Vegas, Nevada. The participating partner locations are The Cosmopolitan, Hard Rock Hotel & Casino, M Resort, Palms, Silverton, Tropicana, and The Venetian | The Palazzo (the “Participating Books”).

Eligibility: Individuals eligible to and who open a new CG sports account (“Account”) during the Promotion Period at a Participating Book (a “New Account Holder”) are eligible to participate in the Promotion.

Specific Rules:

1. Any New Account Holder who makes an initial deposit of at least twenty-five dollars (\$25.00) into their CG wallet account during the Promotion Period will have their initial deposit matched up to a maximum of fifty dollars (\$50.00) (the “Match Deposit”).
Example 1: A New Account Holder who initially deposits one hundred dollars (\$100.00) into their CG wallet account during the Promotion Period will get a bonus deposit of fifty dollars (\$50.00).
Example 2: A New Account Holder who initially deposits twenty-five dollars (\$25.00) into their CG wallet account during the Promotion Period will get a bonus deposit of twenty-five dollars (\$25.00).
2. Match Deposits must be wagered and cannot be withdrawn.
3. Match Deposits expire if the New Account Holder withdraws the initial deposit prior to wagering an amount totaling at least twice the amount of the Match Deposit.

General Rules:

1. CG reserves the right to amend, clarify, extend, alter or cancel all or any portion of this Promotion, for any reason, or for no reason and at any time and without prior notice, in CG’s sole and absolute discretion. These Official Rules and any changes to these Official Rules will be available upon request at the ticket counter of each Participating Book.
2. All participants must be 21 years of age or older with valid government issued identification at sign-up and otherwise eligible to wager.
3. This Promotion is subject to all applicable policies, procedures and rules of CG and the laws of the state of Nevada.
4. All applicable regulatory requirements must be complied with in order for customers to receive Match Deposits, including (without limitation) customer identification. Customers are responsible for all taxes related to their winnings and/or account funds.
5. CG reserves the right in its sole and absolute discretion to exclude any person from participating in this Promotion, including (without limitation) those whose conduct impedes the operation of the Promotion or who are barred from the gaming establishment and to withhold Match Deposits from any individual who abuses the Promotion.
6. Management reserves all rights. The decisions of CG are final in the resolution of any dispute or interpretation of these Official Rules.
7. Employees of CG and their spouses and immediate family members are not eligible to participate in this Promotion. Immediate family members include parents, siblings, children, grandchildren, and the spouses of all of the above.
8. By participating in this Promotion, participants affirmatively assent that they clearly understand, fully accept and agree to these Official Rules, house rules and other rules and terms and conditions that CG may make from time to time. All decisions regarding any interpretation of these Official Rules, house rules and other rules and terms and conditions by CG are final. In the event of any inconsistencies between these Official Rules and any verbal communication, these Official Rules control.
9. These Official Rules shall be governed by the laws of the state of Nevada without regard to its conflicts of laws, principles and rules.
